Changing the name of the Humanistic Studies Program (CD2021170; Usekes) (Motion: Lever/Shoushani) Trying to add coherence to the program and degree by changing "Humanistic Studies" to "Interdisciplinary." Various members of the committee voiced concern by cornering the term "interdisciplinary." Will it impact other departments' course offerings? The name change of the program (not the department) will not be grounds for prohibiting other departments from offering "interdisciplinary." They are not trying to change the degree, just the program. Confusion remains about changing the program and not the prefix. This is something that the Registrar would have to change. Committee recommends new proposal that would change program name and prefixes. Can model their proposal based on that submitted by World Languages and Cultures.
