### III. Old Business

 ANT/ART /HON 3XX – New Course: No Place Like Home (Hegel-Cantarella) (UPDATED: CD2324025) – MSAS PRC suggested modifications from September meeting:

4 things that needed to be changed – all addressed sufficiency (B Stankus)

- Remove the statement about cross-listing course with Honors ("HON 3xx")
- Providing explicit justification for 4-credit offering
- Aligning course pre-requisites with ART department recommendations
- Indicate frequency C Hegel-Cantarella will send the updated document to B Stankus

## **IV.** New Business

- 1. CHE 1XX New Course: General, Organic, and Biological Chemistry for Nursing Professionals (Prieto) (CD2324024)
  - F Robertson presented a motion to consider passing the proposal
  - 120 & 121 is reduced to a one semester offering for CHEM combined all relevant topics in 120 & 121 into this one-semester course
  - The course will still address pharmacology, inorganic analysis
  - This meets the needs of nursing students who will go elsewhere if they have to take two CHEM classes
  - This proposal benefits the nursing department and serves to retain their students
  - K Giamanco suggested adding a description of laboratory activities in the course outline
  - F Robertson said he will add a topical outline for the laboratory activities
  - J Kraybill suggested adding a statement about the course rotation

- 2. CED 130 New Course: Workplace Professionalism for Career Success (K Lindenmayer) (CD2223099) –
- 3. CED 120 New Course: The Employment Process: Skills and Strategies (Lindenmayer) (CD2223100)
- 4. CED 110 New Course: Designing Your Life (Lindenmayer) (CD2223099)
  - The three courses were considered together
  - C Usekes did not support adding these courses because general education courses are being cut
  - K Lindemayer said that students need these courses: taking these courses results in increased retention "we have shown that these are keeping students here;" "helps students understand who they are"
  - M O'Neill argued that they were critically important for student wellbeing and transition to the workplace
  - Only those with specific training are qualified and prepared to teach these courses
  - C Usekes suggested that this content could be delivered in noncredit courses and workshops
  - J Kraybill suggested that students could take the courses for a certificate, rather than for academic credit that would contribute to the required 120 credit hours
  - N Gallucci said that Psychology recently added two courses pertaining to orientation to the major and professionalism
  - F Robertson said that Chemistry is knowledgeable about who hires Chemistry students: the faculty in the content areas should help students with employment; he asked why should students pay for courses if they have access to this content for free and that students already pay for this content with student activities fees
  - K Lindenmayer said that her office has data indicating that job placement and career readiness improve as a result of taking these courses
  - F Robertson remarked that "we embed career content in everything we do; it is in our fiber"
  - K Giamanco discussed differences in applying for jobs in sciences versus nonsciences
  - K Lindenmayer and M O'Neill responded to these considerations: these courses were seen to offer unique benefits for students; students have not accessed these services in significant numbers because they do not receive credit; student assessment was considered including the Odyssey plan
  - F Robertson asked why this information could not be embedded in the first-year orientation courses offered by departments
  - M O'Neill said that first-year students are not ready for these courses
  - There was additional discussion about the evidence that students were in need of these courses and the benefits of these courses
  - A motion to add all three courses to the curriculum was considered (B Stankus/J Kraybill) and did not pass (0 for, 5 against, 1 abstain)

5. By-laws discussion (Usekes) – The discussion this topic was postponed until the next meeting as this meeting extended until 11:00 AM.
