## To our WCSU Community,

Western Connecticut State University ("WCSU" or "University") affirms a commitment to freedom from discrimination for all members of the university community. To appropriately address any issue(s) related to discrimination and/or harassment that may exist on our campuses, member(s) of the university community are strongly encouraged to file a written complaint of discrimination to ODE so that the addressed issue(s) can be directly reviewed and investigated. If you click here, members of our university community can file complaints through the WCSU Anonymous Incident Report System. You are welcome to submit an anonymous ("unidentified person") complaint but note that no reoccurring updates and/or referenced information can shared about the actions taken by ODE. Anyone who submits a file virtual and/or written complaint of discrimination and/or harassment, or who participated in an investigation by providing information, is protected from the negative acts of another who wishes to take any adverse action for making the written complaint or participating in a university investigation. To facilitate prompt responses to filed written complaints of discrimination and/or harassment and/or to preclude conflicts of interest, the Chief Diversity Officer (in certain cases) may designate another WSCU official to consider and/or investigate a written complaint and/or to render a determination.
