#### III. Students with Special Needs

### IV. Statement of Understanding

I understand the following statements, as they pertain to my participation in the stated Course Abroad program, and understand that I will be financially responsible for the cost:

Overall Program Cost:

- The estimated program travel cost is \$3,950.00 (subject to change).\* This includes round-trip airfare from the NY/NJ metro area, transportation to/from the US airport, accommodation and full board on site in Spain (double room), emergency health insurance, airport transfers in Spain, museum tickets and various activities.
- A non-refundable \$1,300.00 deposit is due with this application. It MUST be submitted with this application <u>money order or cashier's check only</u> payable to WCSU. (Bring to Higgins Hall 201) by February 20, 2020
- A \$1,500.00 payment is due by March 19, 2020. (Bring to Higgins Hall 201)
- A \$1,150.00 payment is due by April 2, 2020. (Bring to Higgins Hall 201) <u>The program cost does NOT include:</u>
  - WCSU tuition and fees
  - Visa, if required / Valid Passport (required) The validity of the passport has to extend to six months after the date of departure from Spain
  - Recommended trip cancellation insurance (available through an insurance company)
  - Personal expenses / incidental items
  - Local transportation

**<u>\*Note:</u>** In the event that WCSU is charged additional direct costs by 3<sup>rd</sup> party providers, WCSU will charge participants for these direct costs. For example, on occasion, the airline will charge a gas surcharge or luggage fees. This direct cost would be added to your program travel cost. It is rare that this happens, but there is a possibility.

#### Cancellation Policy and Fees:

The deposit of \$1,300.00 is non-refundable. In order to cancel travel arrangements without losing the travel cost, written notice of the withdrawal must be received by WLC secretary, Higgins Hall 201, prior to close of business (4:00 pm) on **February 20, 2020**. If cancelling after this date, you will be charged for any direct costs incurred by WCSU on your behalf, as well as a \$200 cancellation penalty. Because cancellation fees can be <u>as high as the full cost of the travel program</u>, purchasing independent trip

cancellation insurance/interruption insurance from an insurance company is highly recommended. If WCSU cancels the program for any reason, all monies will be refunded. Withdrawal/cancellation of the course(s) should be addressed with Dr. Galina Bakhtiarova (Higgins 218B). (Registration drop fees may also be charged, depending when you cancel/drop.)
