Referral Source:

Client was approached and asked to participate.

REASON FOR REFERRAL:

Client willingly agreed to engage in the testing to learn more about himself.

Clinical Interview:

Family History: Client reported being born in Danbury, CT and has been raised in Another Town, CT his whole life. Client has moved once, from one house in Southbury to a new one because of the landlord choosing to sell the house.

Client reported being the youngest in his family, with one older sister. He described his relationship with his sister as being "fine". In regards to his parents, Client reports that he gets along with them, stating that he "deals with them". When asked about childhood trauma or abuse, he stated he had a normal childhood with no trauma or abuse. Client currently lives with his mother and father, his sister goes to university out of state the majority of the year.

Medical: Client indicated his current health condition is "healthy." He reported no illnesses or injuries from childhood.

Alcohol/Drugs: When asked about drinking, Client stated “not really” and indicated that he only drinks about once a month and indicated he drinks “socially” when with friends. Client minimized his drinking, and only has “a couple” of drinks at a time. Client stated that he began drinking when he was 15.

Regarding drug use, Client admitted to smoking marijuana regularly (once-twice a week) when he was 15-16 years old. He indicated he currently does not smoke marijuana but will now smoke cigarettes “socially” instead.

Education/Career: Client stated that he is currently enrolled in Pomperaug High School in Southbury, CT. He indicated that he is going to start classes at Bristol Tech in the fall; however the credits will go towards a degree from Pomperaug. Client stated that he has grades in the C-D range that his favorite class is history because he “finds it interesting”. Client’s least favorite class is English, stating that “I already speak English and it’s boring”.

Client stated that after Pomperaug, he was going to apply to Naugatuck Valley Community College to get his associates degrees in Paramedic, Fire Science and Engineering.

Behavior Observations:

Client arrived on time for his testing session. He was dressed appropriately for the setting and the weather outside. He was well groomed with adequate personal hygiene. He was cooperative and calm with no attention difficulties.

Results:

To screen Client’s cognitive functioning, he was administered the Kaufman Brief Intelligence Test – 2nd Edition (KBIT-2). The KBIT-2 is a reliable and brief. His IQ composite score of 126 placed him in Above Average overall. His Verbal Standard Score was 118 and his Nonverbal Standard Score was 126; both of which place him in Above Average functioning range. These scores suggest that Client’s cognitive functioning is similar to above the intellectual abilities of the majority of the population. Through these scores, it appears that cognition should not be a barrier to Client’s functioning in the community. His specific scores are as follows:

Client was administered the Behavior Assessment System Second Edition (BASC-2).

Client's T Score on Test Anxiety is 44 and has a percentile rank of 29, reporting that he experiences test-related anxiety no more often than others his age. His T score on Anger control is 43 and has a percentile rank of 28 reporting that he responds to adversity in a manner typical of others his age. His T score on Mania is 32 with a percentile rank of 1, reporting that he has extended periods of heightened arousal and difficulty relaxing slightly less often than others do his age. Client's T score on Ego Strength is 55 and has a percentile rank of 64, reporting a level of self-identify and emotional competence that is typical of others his age.

Overall Functioning

Client was administered the Mini Mental State Examination. He received a total score of 30/30 answering the questions all correctly.

Summary:

Overall Client scored average or above average in all categories for his age norm.

Recommendations:

1. Refer Client for counseling to address these issues:
 - a. His relationship with his parents
 - b. Lack of motivation in school
