## Introduction

The Western Connecticut State University Police Department (WCSU PD / WestConn PD) is pleased to submit the annual Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics report for 2025 to help inform and increase your awareness of the current programs that exist to assist you in protecting your safety and wellbeing.

The report for 2025 includes mandated crime statistics for the 2024, 2023 and 2022 calendar years. These statistics represent certain reported crimes that occurred on campus, on non-campus property and on public property. Incidents occurring within residence halls are also listed and are a subcategory within the on-campus reportable crimes. These incidents are further categorized for each of WCSU's two campuses: Midtown and Westside.

Additionally, all Clery Act reportable crimes from NVCC occurring in the classrooms or offices assigned to WCSU are listed under the non-campus crimes on the statistical charts in this report. This category also contains crimes occurring in the hallways and stairwells leading to those rooms as well as in the parking lot used by our students.

The report also contains various policy statements regarding crime reporting; access to campus facilities and residence halls; general security considerations; enforcement and arrest authority of the WCSU PD and their relationship with federal, state and local law enforcement agencies. These policy statements and others concerning crime reporting and sex offense procedures are mandated by the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, formerly known as the Campus Security Act of 1990. The Higher Education Opportunity Act (Public Law 110-315 - HEOA) mandates several additions that are contained in this report and requires that campuses also publish an Annual Fire Safety Report. ## Report Preparation and Data Gathering

The process to prepare this report involves several steps beginning with a review of the most recent calendar year's crime statistics. For this report, the crimes reported in 2024 and investigated by the police department were reviewed and categorized. Those incidents and crimes categorized and reportable as defined under the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act are included in this report.

In addition, information received and contained in reports from anonymous reports made to the police department are included in the statistical information for sex crimes, domestic violence and stalking, as per the provisions of the federal Violence Against Women Act (VaWA).

WestConn PD also requests crime statistics under the Clery classifications from the Danbury Police Department. Those crimes are incidents that occurred on public properties immediately surrounding the campuses. These crimes are recorded in the crime statistics under the public property classifications.

Finally, non-reported crime data is obtained from various staff and faculty members who are considered campus security authorities (CSAs) under the act. They include senior administrators and staff who may have received anonymous reports from students who do not wish to pursue criminal complaints as well as various members of the Student Affairs Department who adjudicate university policy violations, which may also include defined Clery Act violations. Although the police do not investigate these reportable incidents, they are included in the statistical report to provide as complete a picture as possible of the safety and security environment on campus.

After these reportable incidents are tallied, they are analyzed and reported in the annual Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Report.



## WCSU Police Department Authority & Structure


The WCSU PD is established in accordance with Section 10a-156b of the Connecticut General Statutes, which provides for a special police force at WCSU whose members have the same duties, responsibilities and authority as members of a duly organized local police department. The department is accredited by the Connecticut Police Officer Standards and Training Council (POSTC) and advanced to the highest level of Tier III accreditation status in early 2025.

The jurisdiction of the department extends to the geographical limits of the property owned or under the control of WCSU (see Appendix IV – map of WCSU Campuses). However, the department has statewide jurisdiction in felony cases, in accordance with Connecticut General Statutes, and is empowered to serve any warrants issued by the Superior Court anywhere in Connecticut for crimes committed within the jurisdiction of the WestConn PD.

The WestConn PD provides a full range of police services on a 24 hour, 7 days a week basis to ensure the safety and protection of the university and its population of more than 5,000 faculty, staff and students, of which approximately one thousand reside on campus, as well as visitors.

The WCSU PD is led by the Chief of Police who serves as the university's Chief Law Enforcement Officer & Director of Public Safety. The Chief reports to the University's president; and works in cooperation with other university departments, offices and services to provide a safe and secure learning environment. The Chief also works collaboratively with outside municipal, state and federal law enforcement and public safety professionals.

The primary function of the police department is to provide a uniformed police presence, respond to calls for service and emergencies, protect the general public and to preserve peace. WCSU police officers patrol both campuses in vehicles, on bicycle or on foot. The department is also responsible for the law enforcement functions of crime prevention; arrest and prosecution of criminals; crime suppression; order maintenance and crowd control; special events safety management; vehicular and pedestrian traffic regulation; traffic enforcement and parking control.

The police lieutenant, who serves as the department's executive officer (second in command), manages the patrol function, police dispatch, community services initiatives and crime prevention activities of the department. The lieutenant is in command of the department in the absence of the Chief.

A police sergeant supervises each of the three patrol shifts. Sworn police officers are assigned to each shift and perform all primary law enforcement functions. Buildings and Grounds (non-sworn) Officers (B&G Officers), assigned to each shift, serve as communication dispatchers and perform security patrol functions as needed.

The police department is committed to the development and implementation of proactive programs that enhance public safety at WCSU and continually seeks opportunities to strengthen ties to the community it serves. The department provides crime prevention and safety awareness presentations in collaboration with our academic programs and actively participates in several campus support services groups, including the Student Care Team (SCT), the Threat Assessment Team (TAT), and the Campus Response and Resource Team (CaRRT). ## About the WestConn Police Department

The WestConn PD maintains a close working relationship with all law enforcement agencies including the Danbury Police Department, other area local police departments, the Connecticut State Police, the State Superior Court based in Danbury and federal law enforcement agencies. Meetings are held on both a formal and informal basis and crime-related reports and statistics are routinely exchanged. WCSU has a formal written memorandum of understanding (MOU) for mutual aid as per Connecticut General Statutes Section 7-277a (b) with the Danbury Police and all police agencies in Northern Fairfield County.

University police officers patrol the campuses 24 hours a day, seven days a week, and are always ready to provide emergency and non-emergency assistance and service. All police officers are equipped with two-way radios as well as body cameras when on duty.

All WCSU PD police officers are certified by the State of Connecticut Police Officers Standards and Training Council (POSTC) and are empowered by state law to arrest, carry firearms and provide the same law enforcement services that local police provide for a city or town. In addition to police academy training, university police officers also regularly attend scheduled in-service training programs in areas such as First Aid/CPR, de-escalation, behavioral health emergencies, legal updates, substance abuse, and defensive tactics.

The WestConn Police Department is accredited by the State of Connecticut POSTC, recently achieving the highest Tier III level. Accreditation demonstrates the department's commitment to the professionalism of Connecticut Law Enforcement through compliance with contemporary, internationally recognized standards of excellence and professionalism.

All of our officers are certified in First Aid and cardiopulmonary resuscitation (CPR) and have been trained to operate the automatic external defibrillators (AEDs) that are deployed in all our marked police cruisers and in many of the University's facilities. They also receive training on mental health crises and suicide prevention.

Officers are given the opportunity to regularly attend professional development programs and courses geared to enhancing their effectiveness on campus. We currently have officers who are certified as crime prevention specialists.

The WCSU Police Department maintains access to the Connecticut On-Line Law Enforcement Communications Teleprocessing (COLLECT) System, which is utilized throughout Connecticut to access valuable online State and Federal law enforcement resources. The police department has two-way radio communication interoperability with the Danbury Police, Danbury Fire & Danbury EMS, as well as the Fairfield County Police Emergency Network (FAPERN). The police can be reached for any emergency by calling or texting 911. For routine calls, calling (203) 837-9300 from any phone on campus anytime, day or night, will bring a direct response by WCSU Police. An officer will be immediately dispatched to provide whatever assistance is required. 911 calls from campus phones go directly to the City of Danbury Emergency Telecommunications Center and are concurrently displayed at the WCSU Police dispatch center's E-911 display computer. The city's 911 Center, at Danbury Police Headquarters, relays 911 call information to the WCSU PD, located on Roberts Avenue on the Midtown campus, to facilitate response coordination.

## Reporting a Crime

If you become the victim of and/or are witness to a crime, you should immediately report it to the WCSU PD or the appropriate law enforcement agency if off campus. The sooner crime is reported, the better the chances of the police being able to solve the crime, apprehend the suspect(s), and recover any property that may have been taken. We encourage our community to report all crimes accurately and promptly to the appropriate police agency.

Crimes on WCSU property can be reported by calling the WCSU PD at (203) 837-9300 (and by calling or texting 911 for emergencies) or in person at the police station on Roberts Avenue, directly across from the Midtown Student Center. You may also use one of the emergency phones on campus. An officer will be dispatched to your location to begin an investigation of the crime. The officer will want to know some basic information about you as the complainant and the incident you are reporting. You may be asked to give a signed statement attesting to the facts of the incident.

Police will record all information provided and will subsequently acquire more pertinent details through thorough investigation as they work towards solving the crime.

## Confidential Reporting Procedures

If you are victimized by crime and do not want to pursue action within the university system or the criminal justice system, you may still want to consider making a confidential report. With your permission, the WCSU PD can file a report on the details of the incident without revealing your identity. The purpose of a confidential report is to comply with your wish to keep a matter confidential, while taking steps to ensure the future safety of yourself and others. This information allows the university to keep an accurate record of the number of incidents involving our community and determine if there is a pattern of crime related to a particular location, method, or assailant so the campus community can be alerted to potential danger. Reports filed in this manner are counted and disclosed in the annual statistics for the institution, including through the Clery reporting requirements. Pastoral and professional counselors also may encourage clients to make voluntary, confidential crime reports.

## **Timely Notice**

In accordance with the Clery Act, the university will issue a crime alert as soon as possible to help prevent similar incidents. The notices will be for crimes listed in the Clery Act that are reported to the WCSU PD or other campus security authority and/or the Danbury Police and that represent an ongoing threat to others on campus. The department has implemented a system to send out these alerts through email blasts to our populations to enhance and accelerate the alerting process. WCSU also has an Emergency Notification System (ENS) through Everbridge for time sensitive notifications of which all university community members are opted in. ## Daily Log

The WestConn PD maintains a daily log of all crimes reported to the department. The log lists the nature of the crime, the date, time and general location of the crime and the disposition of the complaint if known. Entries or updates may be withheld for up to two business days if the information is protected by statute or if there is a danger to the victim. The daily log is open to public inspection at the WCSU Police Department web site <a href="https://www.wcsu.edu/police/logs.">https://www.wcsu.edu/police/logs.</a>. Data more than 60 days old will be made available within two business days of a request for public inspection.

## Uniform Crime Reports (UCR) and the Clery Act Statistics

WCSU police participate in both the Connecticut Uniform Crime Report (UCR) Program, and National Incident Based Reporting System (NIBRS). Every month we submit UCR data indicating the number of offenses brought to our attention. The offenses that are reported are called Part I (crimes against the person) and Part II (crimes against property) crimes. Part I crimes include murder, forcible and non-forcible sex offenses, robbery, and aggravated assault. Part II crimes include burglary, motor vehicle theft and arson.

These crimes are also mandated by the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act to be reported and distributed annually on October 1, through the WCSU PD's Annual Report to all current students, faculty and staff. The statistics gathered for this report include: all crimes in these categories reported to the police department that occurred on campus and in residence halls; incidents that occurred on public property immediately surrounding the campus that were reported to the WCSU PD or to the Danbury Police Department; incidents that occurred on non-campus property; and incidents not reported to the police that may have been reported confidentially to a campus security authority. The report also contains statistics for arrests and referrals to the campus judicial process for liquor law violations, drug abuse violations and weapon law violations as well as VaWA (Violence Against Women Act) statistics such as stalking, domestic and dating violence.

## Hate Crimes

Federal and State law requires that all hate crime in the mandated categories be reported. Those crimes are further broken down by the nature of the bias; for example, race, gender, religion, sexual orientation, ethnicity and disability. The revised regulation adds the hate associated crimes of larceny-theft, simple assault, intimidation, and destruction/damage/vandalism of property to the list of crimes that must be reported in hate crime statistics. We also report hate crimes as classified by state statutes to the State Police Crime Analysis Unit.

## Incidents Resulting in Serious Physical Injuries or Death at Institutions of Higher Education

The Connecticut General Assembly passed <u>Public Act 21 – 184</u>, An Act Requiring the Reporting of Incidents that <u>Resulted in Serious Physical Injuries or Death at Institutions of Higher Education</u>. This Act adds a new reporting requirement to the annual uniform campus crime report that all Connecticut colleges and universities prepare. It requires the institutions' reports to include the number of accidents that occurred in the immediately preceding calendar year on the property that they own or control and result in (1) serious physical injury and (2) death. This property includes campuses or dormitories in another country that an institution owns or controls for purposes of an international studies or international exchange program.

WCSU had no reports of accidents that resulted in serious physical injury or death on any property owned or controlled by the university for the year 2024.



The following three pages show the mandatory statistics for the calendar years of 2024, 2023 and 2022. The data reflects the specific crime categories specified in the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act for both our Midtown and Westside campuses.

## Response to Sexual Assault, Interpersonal Violence, Dating Violence and Stalking

Sexual crimes, interpersonal violence of any type, domestic and dating violence and stalking are not only crimes under the federal Violence Against Women Act (VaWA) and Connecticut General Statutes, but they are also a violation of the institution's rules and regulations. WCSU provides educational programs on campus to raise awareness of rape, acquaintance rape and other sex offenses. These programs take place regularly in the Student Centers, in residence halls and elsewhere on campus. The WCSU PD Training Sergeant coordinates requests for police participation in these programs in conjunction with departments such as Housing and Residential Life, Counseling Center, CHOICES Office, Health Services, Social Work department, Nursing department, and others. All are responsible in ensuring these programs are made available and implemented at WCSU on an ongoing basis. Sexual assault and intimate partner violence primary prevention and awareness programming are available for all students and the programming will:

- 1. Explain the definition of consent in sexual relationships; and
- 2. Provide information on the reporting of such assaults and violence, bystander intervention and risk reduction.

If you become a victim of, or witness to, a sex offense, interpersonal violence or stalking, then report it immediately to the WCSU PD by calling 911 or (203) 837-9300, 24-hours a day, 7-days a week or contact any onduty police officer on campus. Your identity as a victim will be kept confidential by law. It is extremely important that sex offenses be reported immediately so that the crime scene and any evidence of the crime can be preserved and secured as soon as possible. It is also critical that you seek prompt medical attention so that you can be screened for sexually transmitted disease and pregnancy and so that a sexual assault evidence collection kit can be administered.

Assistance is available to you on campus through the WCSU PD, the Office of Housing and Residence Life (HRL), the Counseling Center and Health Services. Off-campus services also are available through the Center for Empowerment and Education (formerly the Women's Center of Danbury) and their Sexual Assault Hotline, which is staffed 24-hours a day, 7-days a week, at (203) 731-5204. The center also provides a Domestic Violence Hotline at (203) 731-5206. The Center for Empowerment & Education (CEE) has an advocate on campus who can be reached at (203) 837-3939. Additionally, the Danbury Hospital Emergency Department is another potential resource; and their number is (203) 797-7100.

In addition to notifying law enforcement, you also have the right to receive services from campus authorities under the Campus Resource and Response Team (CaRRT). Additional information is available at: <a href="https://www.wcsu.edu/diversity/carrt/">https://www.wcsu.edu/diversity/carrt/</a>.

If you live on campus and experience an unsafe situation, the Office of Housing and Residence Life (HRL) can, at your request, change your living situation to whatever extent is possible and reasonable. Furthermore, they can assist the Dean of Students Affairs to have your academic situation changed if you choose to do so.



## Title IX at WCSU

The Title IX Office is responsible for ensuring compliance with Title IX, a federal law that prohibits sex-based discrimination in educational programs and activities. This office handles reports of sexual harassment, sexual assault, gender-based discrimination, and other forms of sexual misconduct. It provides support and resources to those affected, conducts investigations, and works to promote a safe, inclusive, and equitable campus environment through education, prevention programs, and policy enforcement.

The Title IX policy applies to all faculty, staff, employees, students and other individuals participating in or attempting to participate in our education programs and activities, including but not limited to contractors, vendors, visitors, guests, or other third parties.

The Title IX Office is located within the Office of Diversity, Equity and Inclusion, Old Main Room 302, on the Midtown Campus. ## Campus Judicial Action

In cases of an alleged sex offense, when the accused is a student, both victim and the accused are entitled to have others present during a disciplinary hearing. You can:

- 1. be accompanied to any meeting or proceeding by an advisor or support person of your choice, provided that the advisor or support person does not cause a scheduled meeting to be delayed or postponed;
- 2. present evidence and witnesses on your behalf;
- 3. be informed in writing of the results of the disciplinary proceeding no later than one business day after it concludes; and
- 4. have your identity kept confidential, except as necessary to conduct a disciplinary proceeding or as permitted by state or federal law.

Additionally, both the victim and the accused must be informed of the outcome of any university disciplinary proceeding. You have the right to request that disciplinary proceedings begin promptly and know that an official trained in issues relating to sexual assault and intimate partner violence must conduct the proceeding. The judicial process will use the "preponderance of evidence standard" (i.e., whether it is more likely than not that the alleged incident occurred).

Following a final determination of responsibility in the university's disciplinary proceeding regarding rape, acquaintance rape or other sex offense, the university judicial officer may impose any sanction or combination of sanctions, including expulsion, as described in the Student Code of Conduct. The Office of Judicial Affairs is responsible for administering the student discipline system.

## Victims' Assistance

All victims have rights that include:

- ·Assistance in obtaining immediate medical care, if required.
- •The right to request to be notified of court proceedings, including arrest, arraignment and release of the offender.
- •The right to be protected from harassment from an employer for appearing as a witness if you have received a subpoena.

- •The right to have property returned if it was seized by police in the investigation or prosecution of the crime committed against you.
- •The right to make an application for compensation for any bodily injuries you have suffered as a result of the crime.
- •The right to request to be informed of services and agencies that can help you, including the assistance of a victim's advocate.

## Sex Offender Registry Notice

In accordance with Chapter 969, Section 54-258 of the General Statutes of Connecticut, the Western Connecticut State University Police Department keeps a record of all registration information transmitted from the Connecticut Department of Public Safety. This registration information is accessible to the public at WCSU PD.

The State of Connecticut Department of Emergency Services and Public Protection, Division of State Police publishes and maintains the Sex Offender Registry on their website. ## Crime Prevention Programs, Security Awareness Programs and Other Services

Crime and criminality are problems of concern to the entire community, not problems of the police alone. The police are charged with preventing and suppressing crime; and solving crime once it occurs and do these things to the utmost of their ability. However, they are realistically aware that they can neither prevent all crime from occurring, nor solve every crime that does occur. To attain the greatest possible degree of success in these endeavors, we strive to obtain the active cooperation, assistance, and moral support of the people we serve.

Crime takes place in our society at large, and unfortunately, the problem does not disappear at the edge of the campus. Thefts, assaults, and other violations of the law do sometimes occur at WCSU, as at other colleges. It is not likely you will be a victim of crime here, but it is possible. Recognition of this fact is a good first step in avoiding becoming a victim of crime. We can all further reduce the risk of victimization by thinking about our personal safety and taking precautionary measures.

The WCSU PD has a wide variety of information on various topics such as self-protection, rape prevention, theft prevention, etc. In addition, there are specialized topics of interest, which include substance abuse disorder, driving while intoxicated and cybercrime. The department sponsors a speaker's bureau, where university police officers, with expertise in particular areas, can address the community about topics of concern.

#### THREAT ASSESSMENT TEAM (TAT)

The Chief of Police is a member of the University's Threat Assessment Team (TAT). This is a specialized group composed of senior leadership, faculty, staff, and mental health professionals dedicated to identifying and mitigating potential threats to campus safety. The team employs a multidisciplinary approach, assessing situations involving students or staff that may pose a risk of harm to themselves or others. The team utilizes a collaborative model and follows nationally recognized guidelines and best practices; gathering information from various sources, conducting risk assessments, and implementing intervention strategies. The team's primary goal is to promote a safe and supportive campus environment through prevention, early intervention, and education. #### **RED FOLDER**

The Red Folder Initiative is a nationally recognized program designed to help university staff and students recognize and respond to signs of students in distress or crisis. It includes a set of resources, guidelines, and protocols to support individuals who may be struggling with mental health issues, personal challenges, or academic difficulties.

WCSU adopted the program during the 2024-25 academic year as part of the university's deep commitment to campus safety and mental health awareness. The Red Folder contains a quick-reference guide outlining key warning signs, emergency contact information, and step-by-step instructions for effective intervention. By empowering the campus community with this vital information, the Red Folder Initiative plays an essential role in fostering a proactive, supportive, and responsive environment.

#### SAFETY ESCORT SERVICES

This service is available to all students, faculty, staff and guests of the university. A safety escort is as close as the nearest telephone. To obtain a safety escort, call the WCSU PD at (203) 837-9300 or activate any emergency or courtesy phone on campus.

When the dispatcher answers, let them know you wish to obtain an escort. The dispatcher will request your name, present location, and the location to which you wish to be escorted. The dispatcher will then dispatch an officer to meet you. Uniformed police or buildings and grounds officers of the department can provide safety escorts at any time.

#### **EMERGENCY TELEPHONES**

The university has an emergency telephone system ("Blue Light" phones) that places the caller in direct contact with the WCSU PD dispatcher. These phones are highly visible either in a bright yellow phone box or a surround type stainless steel phone with blue strobe light and are located at various places around both campuses (inside and outside of buildings). The phones have a single button operation which, when pushed, will immediately notify the dispatcher of the caller's location. The caller can speak directly into the phone box for hands-free communication.

There are also emergency phones inside all elevators which connect directly to the WCSU PD dispatch. Users can report emergencies, request assistance, or communicate any concerns. These phones are equipped with clear instructions and often have a prominent emergency button. Help can be summoned quickly in situations such as power outages, medical emergencies, or elevator malfunctions. In addition to emergency phones, the university has installed courtesy phones that provide intra-campus calling. Courtesy phones are located on each floor of academic buildings, in the Honors House and in all residence halls. The WCSU PD can be reached from these phones by calling (203) 837-9300 or 911.

#### SECURITY CAMERAS

Security cameras serve as a crucial tool for enhancing campus safety and security. WCSU has over 500 cameras strategically placed in high-traffic areas, entrances, parking lots, and building perimeters to monitor activity in real time. These cameras help deter criminal behavior, provide evidence in the event of incidents, and assist security personnel in responding quickly to emergencies. Additionally, they support the overall safety of students and staff by fostering a sense of security and enabling effective incident management. Privacy considerations are taken into account, ensuring that camera use complies with relevant regulations and respects individual rights.

#### **COMMUNITY EDUCATION INITIATIVES**

In addition to the crime prevention programs listed above, the WCSU PD has collaborated with several departments on campus to provide personal safety and security educational programs to the campus community annually. Although most of these activities are geared for students, several faculty and staff have attended and participated in these programs. The department assigns officers to participate in campus-wide student programs such as Alcohol Awareness Week events and the annual Health & Wellness Fair.

The Housing and Residence Life group (HRL) also sponsors organized student education and awareness programs each year; and the WCSU PD is regularly invited to participate. Presentations are given to both parent and student orientation groups in the summer and during Welcome Week at the start of the fall semester.

The WCSU PD presents safety orientation programs to various university divisions and organizations, including senior administration, faculty, and AccessAbility Services. Programs in the management of aggressive or concerning behavior, theft prevention, work safety and emergency management have been presented to various groups of employees.

These community education initiatives are designed to inform students, parents and employees about crime prevention and personal safety and to encourage everyone in our community to look out for themselves and for one another.

## Access to Campus Facilities

The academic and administrative buildings on campus are open to the public during normal business hours. Many facilities have individual hours, which may vary at various times during the year. Access to some of these buildings is controlled by card access after normal business hours. Access can be requested from the WESTCONNect Card Office in Old Main, suite 013. For information about access protocol to a specific building, see the department manager or contact the WESTCONNect Card Office at 203-837-9311.

#### RESIDENCE HALL ACCESS CONTROL

Access to residential buildings is restricted to residents only. The door to your apartment is locked by a cardreader mechanism and your university identification card acts as the "key" to your apartment. Please make sure that you do not give your card to anyone else. If your card is lost, you should report this to your resident assistant immediately. There is a fee to replace an identification card.



#### **RESIDENCE HALL GUEST POLICY**

Guests are permitted to visit during the hours of desk operation. Guests must present valid government issued photo ID at the information desk to be admitted to the building. All guests must be 18 years of age except for family members of current residential university students. Visitors must be met by residents at the front desk and always escorted. Guests may be signed out, thereby relinquishing responsibility for them or their actions, but the guests will be directed to leave. Guests who appear to have stayed more than three days will be considered living illegally in the residence hall room and will not be permitted to continue to sign into the building. No more than two guests per resident may be signed into a residence hall; and while on campus, they must adhere to all rules and regulations listed in this document and in the WCSU Student Code of Conduct which can be accessed at WCSU Office of Judicial Affairs; and follow all Housing & Residence Life Policies.

## Alcohol, Drug and Weapons Policies

The university does not condone violations of those laws regarding possession, use, or sale of alcoholic beverages and possession, sale, use, manufacture or distribution of illegal drugs. In addition to arrest and prosecution, administrative action, which may include eviction from the residence halls, revocation of other privileges, or suspension or expulsion from the university, may be taken to protect the interests of the university and the rights and safety of others.

#### **ALCOHOL & PROHIBITED SUBSTANCE POLICIES**

- 1. Possession or consumption of alcoholic beverages by persons under the legal drinking age (21) is prohibited.
- 2. The possession or consumption of alcoholic beverages by persons of legal drinking age (21) is permitted in individual rooms only.
- 3. Possession or consumption of alcoholic beverages in public areas within and around the residence halls is prohibited. This includes the hallways, practice rooms, computer rooms, lounges, bathrooms and properties adjacent to the residence halls.
- 4. Possession or use of kegs, beer balls, and other containers of alcohol larger than a quart (and not intended or designed for individual consumption) is prohibited.
- 5. Alcoholic beverages may be transported into the residence halls by persons of legal age (21).

- 6. Room parties, with or without alcoholic beverages, are not permitted in the residence halls. A party is not contingent upon a set number of people, but upon the activities in which the people are involved.
- 7. The use of residence hall social fees for any event where alcoholic beverages are available is prohibited.
- 8. The possession or use of illegal drugs, including but not limited to cocaine, heroin and methamphetamine is prohibited on university property. Marijuana, while legal in the state of CT, is illegal under Federal Law and is prohibited on university property per US Department of Education Policy. This includes inside vehicles parked in university-owned parking garages, roadways and surface lots.
- 9. WCSU has been a smoke-free campus since 2023. Smoking, including the use of cigarettes, cigars, pipes, and electronic cigarettes or vapes is prohibited in any university-owned building, outdoor space or vehicle.

The WCSU PD encourages all community members to report suspected violations; and can do so anonymously. Counseling and support services for individuals struggling with substance abuse are available through the Student Health & Wellness Center, located in Newbury Hall on the Midtown Campus.

#### FIREARMS/WEAPONS POLICY

All members of the WCSU community have a responsibility to use due care for their safety and to comply with all federal, state, and local laws and university regulations. In the interest of public safety, no employee, student, visitor, or guest (except authorized members of a duly organized law enforcement agency) shall bring any weapon or dangerous instrument as defined below anywhere on the property owned or under the control of WCSU. Anyone (faculty, staff, students, or guests) with a concern about personal safety is encouraged to contact the WCSU PD.

Weapon means any firearm, including: a BB gun (loaded or unloaded); any knife (excluding a small folding knife with a blade of three inches or less), including a switchblade or other knife having an automatic spring release device; a stiletto; any police baton or nightstick or any martial arts weapon or electronic defense weapon. A 'dangerous instrument' is any instrument, which can cause injury or death if used as a weapon. Any weapon or dangerous instrument on campus will be confiscated and, depending on the nature of the instrument/weapon in question, its possession may lead to university disciplinary action or arrest.

## Missing Student Notification

In the event a student is deemed to be missing from our residence halls or from the campus, all persons are directed to report this fact to the university police department. Reports should also be made to the housing and residence life department and/or the dean of students' office. The university police will begin an investigation and attempt to find the missing person immediately upon receipt of the information. Under state law as well as police department protocols, the person does NOT have to be missing for 24 hours before these actions are taken, but rather as soon as it is determined that the person is missing.

Each student living on campus has the option to register a confidential contact person to be notified in the event the student is determined to be missing. Only authorized campus officials and law enforcement officers, in furtherance of a missing person investigation, may have access to this information. All students, even if they have not registered a contact person, are advised that the local law enforcement agency will be notified the student is missing. The parent(s) or guardian(s) of any student under 18 years of age and not emancipated must be notified as well.

Official missing student reports are to be referred immediately to the WCSU PD and/or the local police department. Missing students can be reported by calling the dispatch center at WCSU PD (203) 837-9300 or by dialing 911.

## Emergency Notification System and Emergency Response

WCSU, and other Connecticut state universities and community colleges, have implemented an Emergency Notification System (ENS) to facilitate urgent and time sensitive communications including those related to inclement weather closures. The ENS used is Everbridge. All students and faculty/staff are automatically enrolled with their university email address and are encouraged to update their profile additional contact methods so they can receive notifications quickly. The implementation of this system reflects the university's commitment to the protection and preservation of the life, health and safety of the campus community and to safeguard the operations of the institution. The system is designed to quickly send emergency notifications and provide information and protective action to campus members through various electronic media to include voice or text messaging to any landline or cell phone, as well as email.

- WCSU will immediately notify the campus community upon confirmation of a significant emergency or dangerous situation involving an immediate threat to the health or safety of students or employees occurring on the campus.
- The institution will, without delay and considering the safety of the community, determine the content of the notification and initiate the notification system unless the notification will, in the professional judgment of the police department, compromise efforts to assist victims or to contain, respond to, or otherwise mitigate the emergency.
- When a situation is reported to WCSU PD, the department will immediately respond and investigate. An activation approval process has been developed involving key university administrators who will approve the release of the notification. In dire emergencies, this task may fall to the police department to not delay the notification.
- The university uses the Incident Command System (ICS) structure for emergencies and the system
  would be implemented when the release of information is deemed necessary and appropriate. In most
  instances, activation of the system would involve approval of the university president.
- Notification methods to the larger community for emergency situations include the ENS, campus email, vehicle and portable public address, the WCSU homepage, student portal, WCSU (WXCI) radio and television and media release/press conferences as necessary.
- The institution tests the ENS system annually.



## **Evacuation Procedures**

All campus buildings are equipped with a fire alarm system that, when activated, alerts the building occupants to leave the premises. Some of these systems have voice public address capabilities and they may also be used if an individual building is involved in an emergency. The Environmental Health & Safety (EHS) department supervises the fire alarm systems on campus and has published the Annual Fire Safety Report cited on page 2 of this document. The police department monitors those alarms around the clock, responds to all activations and notifies the Danbury Fire Department.

#### **POLICE & PUBLIC SAFETY**

#### **EMERGENCY PROCEDURES GUIDE**

#### **CALL 911 IN AN EMERGENCY**

For non-emergency University Police assistance call 203-837-9300

#### FIRE

- · Activate building alarm
- CALL 911
- Evacuate building by walking quickly to nearest exit
- · Close doors behind you
- · Alert others on your way out
- DO NOT USE ELEVATORS
- Move at least 500 feet away from the building
- DO NOT RETURN TO BUILDING until authorized by Fire or Police Department personnel
- Individuals needing assistance should remain in an area of refuge and advise emergency responders of their location by dialing 911

#### **VIOLENT OR CRIMINAL BEHAVIOR**

- CALL 911 if immediate threat
- Give nature of incident, location, any descriptions, weapons, injuries, or property damage
- · Avoid contact with person(s)
- If gunfire occurs, take immediate cover in a locked room and stay until police give clearance

#### PSYCHOLOGICAL CRISIS

- CALL 911 if immediate threat or call the University Police 203-837-9300 if not immediate threat
- Do not try to handle any situation you feel is dangerous on your own
- Contact immediate supervisor, resident director, or resident assistant

#### **ACTIVE ATTACKER**

- Run away if safe, warn others to stay away and CALL 911
- Hide if you can't escape away from attacker's sight and behind locked door or behind heavy objects
- Fight as a last resort, use aggression

#### **EMERGENCY LOCK DOWN**

- Remain inside locked room;
- barricade door if possible
- . Stay silent and out of sight
- Do not open doors until official 'all clear'

#### WORKPLACE VIOLENCE

- CALL 911 if immediate fear of danger
- If not immediate fear of danger, notify supervisor or Human Resources 203-837-8665

#### UTILITY FAILURE

- Dial 203-837-9300 University Police
- · Notify immediate supervisor
- · Wait for instructions
- Cease from using all electrical equipment
- . Do not use on/off light switches

#### MEDICAL AND FIRST AID

- CALL 911
- Give name, location, nature of medical/first aid need
- Provide first aid care, if trained

#### CHEMICAL OR HAZARDOUS MATERIALS RELEASE

- CALL 911
- Try to contain the spill
- · Vacate the affected area
- Close doors behind you
- When reporting a spill, be specific on nature of material involved
- If contaminated by a spill, avoid contact with others
- Showers/eyewashes are located in all chemical areas

#### BOMB THREAT

- CALL 911
- · Attempt to keep caller on line
- · Notify immediate supervisor
- Do not touch or move any suspicious item
- The decision to evacuate will be made by the University Police

#### SEVERE WEATHER WARNING

- Seek area of refuge or shelter
- Stay away from windows
- Visit <u>www.weather.gov</u> for updates

#### CIVIL DISTURBANCE OR DEMONSTRATIONS

- Dial 203-837-9300 University Police
- Avoid location of disturbance/ disorderly demonstrations
- University Police will give directives if in your area

## RED FOLDER

A quick reference guide for recognizing, responding to, and referring distressed students.





**SCAN HERE** 

#### 1. RECOGNIZE

Recognize distress. WCSU faculty and staff are in a position where they have frequent contact with students and may be the first to see that something seems 'off.'

#### 2. RESPOND

Use these important tips when responding to a distressed student ask direct questions; use active listening; and seek consultation.

#### 3. REFER

Refer person in crisis to appropriate services or consultation. Call Police if immediate threat; 911 or (203) 837-9300.

#### SAFETY FIRST.

If there is an imminent danger to the student, you, or others, call WCSU Police (203) 837-9300

#### BE PROACTIVE.

If you notice that something seems off, engage students early on. Waiting could mean that the problem gets worse before you see them

#### STAY CALM.

Take a few deep breaths. Use a calm voice when talking and asking

#### ASK DIRECT QUESTIONS.

Inquire directly if the student is having thoughts of harm to themselves, suicide, or thoughts of hurting others.

#### ACTIVE LISTENING.

Give the student your full attention. Restate or summarize what the student says so that they feel understood

#### SEEK CONSULTATION.

You are not alone. See here that can help.

#### HIGH (RED)

Student's behavior is imminently dangerous to self or others. Student needs immediate assistance.

Call 911 or WCSU Police (203) 837-9300

Student shows signs of distress, but I am unsure of how serious it is. The interaction left me feeling uneasy and/or very concerned about the student. Refer for further assessment at:

#### LOW (GREEN)

I am not concerned for the student's immediate safety, but they are having significant academic and/or personal issues and could use more support. Refer to Student Care Team at:

#### 2025 Annual Fire Safety Report

The Higher Education Opportunity Act, enacted on August 14, 2008, requires institutions that maintain on-campus student housing facilities to publish an annual fire safety report that contains information about campus fire safety practices and standards of the institution.

#### B. Description of On-Campus Student Housing Fire Safety Systems:

All On-Campus Student Housing is equipped with the following fire safety features:

- Complete automatic sprinkler system.
- Fire alarm system with addressable smoke detectors and voice evacuation monitored by the WCSU Police Department.
- Smoke alarm in each sleeping room, interconnected within common areas of suites and apartments. Activation is initially local to the detector of origin and transmits a warning signal to WCSU Police Department. After 1 minute of local alarm

activation, verification of a smoke condition, or activation of a second smoke detector, the system will sound a General Fire Alarm within the building. All fire alarm events, troubles, and supervisory signals are monitored by the WCSU Police Department.

- Upon the receipt of a fire alarm signal by the WCSU Police Department dispatcher, an automatic fire alarm is reported to the City of Danbury Fire Department through the 9-1-1 System.
- Egress corridors and stairwells are fire rated.
- Residents with disabilities are accommodated according to their needs. A list of mobility impaired students is maintained by the University and is reported to the WCSU Police Department.
- The WCSU Police Department is equipped with a Redundant Fire Alarm Command Center.

#### C. Number of regular mandatory supervised fire drills:

Each on-campus student housing facility has at least one fire evacuation drill conducted and evaluated by the University Director of Environmental Health and Safety each semester.

#### D. Policies on portable electrical appliances, smoking and open flames:

On campus housing facilities have prohibitions against the following activities:

- Smoking.
- Using lighted candles or any other open flame devices.
- Cooking in unapproved areas (bedrooms) including use of toaster ovens and appliances with an open heating element.
- Microwaves are permitted only in locations where they have been installed by the University.
- Use of space heaters (Except when issued by Residential Facilities for emergency outages of heat).
- Use of extension cords.

- · Tampering with or blocking any fire protection equipment.
- Possession of fireworks.
- Use of halogen lamps or halogen bulbs.

#### E. Policies for Fire Safety Education for students, faculty and staff:

The Fire Safety Element within the Department of Environmental Health & Safety provides training to Residence Life staff including Resident Assistants, Residence Hall Directors and other administrative staff as necessary. The training includes annual R/A Fire Safety Training. Training provides information on fire protection features of facilities, fire prevention, emergency procedures, and conducting fire safety education sessions for residents, and hands-on fire extinguisher training.

#### F. Plans for future improvements in fire safety:

The University Director of Environmental Health and Safety continually evaluates the fire protection systems within student housing facilities. Evaluations culminate in the incorporation of fire safety upgrades. Such upgrades occur through replacements or building renovations. Current plans include: Upgrading older fire alarm systems.

#### TO MIDTOWN CAMPUS (181 White Street)

From the East: Take Exit 5 off I-84 to first traffic light (Clapboard Ridge Road); turn right and continue on Main Street to White Street (fifth traffic light); turn left onto White Street and continue one-half mile to campus on left.

From the West: Take Exit 5 off I-84 to first traffic light (Main Street); turn right and continue on Main Street to White Street (fourth traffic light); turn left onto White Street and continue one-half mile to campus on left. Visitor parking is available in the lot adjacent to Old Main on the Midtown campus.

#### TO WESTSIDE CAMPUS (43 Lake Ave. Extension)

Take Exit 4 off I-84; turn right onto Lake Avenue. Travel approximately one mile to campus entrance on right.

#### CAMPUS-TO-CAMPUS

Midtown to Westside: Follow White Street and take a right onto Main Street (third traffic light). Follow Main Street to third traffic light (Main Street becomes Clapboard Ridge). Turn left onto I-84 West. Take Exit 4 off I-84. Turn right onto Lake Avenue. Travel approximately one mile. Campus entrance is on the directly across from Stop & Shop. General parking is available along University Boulevard.

Westside to Midtown: Turn left onto Lake Avenue for approximately one mile. Turn left onto I-84 East (third traffic light). Take Exit 5 off I-84 to first traffic light (Main Street). Turn right and continue on Main Street to White Street (fourth traffic light). Turn left onto White Street and continue one half mile. The camous is on the left.
