I hope your Spring is going well! I wanted to provide you with some updates on a few initiatives:

- The DHS TVTP grant is off to a great start. We have been able to provide the <u>**Comprehensive**</u> <u>School Threat Assessment Guidelines (CSTAG)</u> training to over 500 participants representing the multidisciplinary school threat assessment teams from 18 school districts. (Please reach out to us if you want to schedule this training free of charge). Also, our Digital Threat Assessment training for May sold out. However, we have another session scheduled for August 20, 2024. Please visit our <u>training website</u> for the most current information.
- We have received great feedback from our research, "<u>Weapons at Connecticut Public Schools: An</u> <u>Examination of Motives and Prevention Methods 2024</u>." Dr. Lomas and I will be presenting the findings on May 22, 2024, at the <u>Connecticut School Counselor Association (CSCA) Annual Conference</u>.
- We are excited to apply for the <u>Department of Homeland Security Targeted Violence Terrorism</u> <u>Prevention grant</u>. We have a few school districts and law enforcement agencies that are interested in piloting our comprehensive approach to swatting incidents based on our <u>Swatting Guidance</u> and <u>Swatting</u> <u>Checklist</u>.

2024 Renew America's Schools Prize (Deadline: June 13)

Provides funding to help districts build capacity, perform energy audits, and plan/implement energy improvement projects across a portfolio of school facilities.

Please note: This funding opportunity consists of three phases. During Phase 1, competitors will build teams and curate lists of at least 10 schools and school facilities that demonstrate compelling need and eligibility for investment. Phase 1 winners will earn a cash prize of \$300,000 and move on to Phases 2 and 3, during which they will enter and execute Cooperative Agreements with the U.S. Department of Energy.

<u>Students, Teachers, and Officers Preventing (STOP) School Violence Program</u> (Deadline: June 12)

Provides funding to improve school safety by providing students, teachers, and staff with the tools they need to recognize, respond quickly to, and prevent acts of violence. This program seeks to increase school safety by implementing solutions that will improve school climate. Solutions include school-based behavioral threat assessments and/or intervention teams to identify school violence risks among students, technological innovations that are shown to increase school safety such as anonymous reporting technology, and other school safety strategies that assist in preventing violence.

<u>Community-Based Violence Intervention and Prevention Initiative (CVIPI) Research and</u> <u>Evaluation</u> (Deadline: June 18)

Provides funding for rigorous, independent evaluation projects funded under the U.S. Department of Justice, Office of Justice Programs' (OJP) CVIPI. This solicitation includes two funding categories: 1) evaluation research of programmatic sites funded under the OJP FY23 and FY24 CVIPI solicitations; and 2) evaluation research of other community-violence programs.

Community Policing Development (CPD) – Accreditation

CPD is a competitive grant program designed to advance the practice of community policing by providing guidance on promising practices through the development and testing of innovative strategies; building knowledge about effective practices and outcomes; and supporting new, creative approaches to preventing crime and promoting safe communities. The CPD –Accreditation program will encompass three separate solicitations for the following purposes:

- Support for law enforcement agencies seeking accreditation;
- Support and enhancement of existing law enforcement accreditation bodies to facilitate the ability of agencies to become accredited; and
- Establishment of accreditation entities in states that do not have an accreditation body.

Approximately \$6.5 million is available for this program. Applications are due by May 28, 2024 at 4:59 PM ET. Please click <u>here</u> for more information on the 2024 CPD – Accreditation program.

The Fiscal Year 2024 COPS Hiring Program (CHP) is a competitive award program designed to provide funding directly to law enforcement agencies to hire and/or rehire additional career law enforcement officers in an effort to increase their community policing capacity and crime prevention efforts.

Anticipated outcomes of the CHP program awards include engagement in planned community partnerships, implementation of projects to analyze and assess problems, implementation of changes to personnel and agency management in support of community policing, and increased capacity of agency to engage in community policing activities.

School Safety and Reporting Program Resources for the K-12 Community

SchoolSafety.gov released a new **infographic** that highlights strategies and resources to enhance student and school safety through the use of reporting programs. The infographic includes specific actions K-12 schools and school districts can take to enable, improve, and sustain reporting systems and create an environment that empowers students to share concerns. Reduce the threat of violence and enhance student safety by creating a reliable reporting program and school environment where anyone can seek help. Reporting programs for K-12 schools and districts can serve as vital channels for students and school community members to report concerns regarding wellness and safety. When concerns are identified, schools can facilitate early intervention and support for students in need, better address issues such as bullying and suicide risk, and in some cases, prevent potential acts of targeted violence.

There are several actions that schools and districts can take to implement reporting systems and build a supporting culture of safety and trust. These include:

- Establishing a centralized and accessible reporting system by offering diverse reporting avenues, including an option that allows for anonymous or confidential reporting, so that individuals are more willing and able to report.
- Evaluating and addressing reports in a manner that builds confidence and credibility in the reporting process.
- Creating and promoting a supportive school climate by cultivating trusting relationships between students, teachers, and staff and fostering an environment where students feel encouraged and empowered in sharing concerns.
- Providing training and generating awareness so that all members of the school community are educated and reminded about their options to report wellness and safety issues.

Timeless School Safety Strategy Series: Focus on All-Hazards Emergency Planning

It can be challenging for schools not to overfocus on specific hazards, such as potential severe weather events from the onset of spring or violent incidents that have impacted their school or other schools. Community pressure or other stakeholders may often influence the school to focus more time, effort, and resources on one threat or hazard that may have a lower probability of occurring than others. Remember that overplanning for one threat or hazard event may leave your school or district underprepared for threats and hazards that happen more frequently at your school, the community, or region.

A comprehensive school emergency planning process must consider various possible threats and hazards that may impact the school or district, addressing safety needs before, during, and after an incident. This all-hazards collaborative emergency planning approach identifies those threats and hazards that are most likely to impact (or ones that have historically impacted) your area. You can find more information on this emergency planning approach within the <u>Guide for Developing High-Quality School Emergency Operations Plans (School Guide)</u> and The Role of Districts in Developing High-Quality School Emergency Operations Plans (District Guide). In Step 2 of the planning process, described within both guides, understanding the situation by identifying all potential threats and hazards and assessing the risks and vulnerabilities posed by those threats and hazards is an effective planning strategy. About 1 in 4 U.S. teachers say their school went into a gun-related lockdown in the last school year. <u>The Pew Research Center</u> conducted this analysis to better understand public K-12 teachers' views on school shootings, how prepared they feel for a potential active shooter, and how they feel about policies that could help prevent future shootings. 2,531 U.S. public K-12 teachers from Oct. 17 to Nov. 145, 2023 were surveyed. The teachers are members of RAND's American Teacher Panel, a nationally representative panel of public school k-12 teachers recruited through MDR Education. Survey data is weighted to state and national teacher characteristics to account for differences in sampling and response to ensure they are representative of the target population. Data from 2022 survey of U.S. parents was also used.

About 1 in 4 U.S. teachers say their school went into a gun-related lockdown in the last school year by <u>Kiley Hurst</u>

Twenty-five years after the **mass shooting at Columbine High School in Colorado**, a majority of public K-12 teachers (59%) say they are at least somewhat worried about the possibility of a shooting ever happening at their school. This includes 18% who say they're extremely or very worried, according to a new Pew Research Center survey.

How we did this:

<u>The Pew Research Center</u> conducted this analysis to better understand public K-12 teachers' views on school shootings, how prepared they feel for a potential active shooter, and how they feel about policies that could help prevent future shootings.

To do this, we surveyed 2,531 U.S. public K-12 teachers from Oct. 17 to Nov. 14, 2023. The teachers are members of RAND's American Teacher Panel, a nationally representative panel of public school K-12 teachers recruited through MDR Education. Survey data is weighted to state and national teacher characteristics to account for differences in sampling and response to ensure they are representative of the target population. We also used data from our 2022 survey of U.S. parents. For that project, we surveyed 3,757 U.S. parents with at

We also used data from our 2022 survey of U.S. parents. For that project, we surveyed 3,757 U.S. parents with at least one child younger than 18 from Sept. 20 to Oct. 2, 2022. Another 31% of teachers say they are not too worried about a shooting occurring at their school. Only 7% of teachers say they are not at all worried.

This survey comes at a time when <u>school shootings are at a record high</u> (82 in 2023) and gun safety continues to be a topic in <u>2024 election campaigns</u>.

Teachers' experiences with lockdowns

About a quarter of teachers (23%) say

they experienced a lockdown in the 2022-23 school year because of a gun or suspicion of a gun at their school. Some 15% say this happened once during the year, and 8% say this happened more than once.

High school teachers are most likely to report experiencing these lockdowns: 34% say their school went on at least one gun-related lockdown in the last school year. This compares with 22% of middle school teachers and 16% of elementary school teachers.

Teachers in urban schools are also more likely to say that their school had a gunrelated lockdown. About a third of these teachers (31%) say this, compared with

19% of teachers in suburban schools and 20% in rural schools.

Do teachers feel their school has prepared them for an active shooter?

About four-in-ten teachers (39%) say their school has done a fair or poor job providing them with the training and resources they need to deal with a potential active shooter.

A smaller share (30%) give their school an excellent or very good rating, and another

3 in 10 teachers say their school has done an excellent or very good job 30% say their school has done a good job preparing them.

Teachers in urban schools are the *least* likely to say their school has done an excellent or very good job preparing them for a potential active shooter. About onein-five (21%) say this, compared with 32% of teachers in suburban schools and 35% in rural schools.

Teachers who have police officers or armed security stationed in their school are more likely than those who don't to say their school has done an excellent or

very good job preparing them for a potential active shooter (36% vs. 22%).

Overall, 56% of teachers say they have police officers or armed security stationed at their school. Majorities in rural schools (64%) and suburban schools (56%) say this, compared with 48% in urban schools.

Only 3% of teachers say teachers and administrators at their school are allowed to carry guns in school. This is slightly more common in school districts where a majority of voters cast ballots for Donald Trump in 2020 than in school districts where a majority of voters cast ballots for Joe Biden (5% vs. 1%).

What strategies do teachers think could help prevent school shootings?

The survey also asked teachers how effective some measures would be at preventing school shootings.

Most teachers (69%) say improving mental health screening and treatment for children

69% of teachers say better mental health treatment would be highly effective in preventing school shootings

About half (49%) say having police officers

or armed security in schools would be highly effective, while 33% say the same about metal detectors in schools.

Just 13% say **allowing teachers and school administrators to carry guns in schools** would be extremely or very effective at preventing school shootings. Seven-in-ten teachers say this would be not too or not at all effective.
